LICENSE TYPE

Trade License

A trade license allows the holder to carry out trading activities including import, export, re-export, distribution, and storage of specific products.

Service License

A service license is geared towards service-oriented businesses and enables an entity to provide services specified in the license.



General Trading License

A General Trading license allows the holder to trade in general activities including import, export

COMPANY OWNERSHIP TYPE

1. DWC LLC(Single owner)

The FZCO company type is similar to a limited liability company that can operate within the Free Zone. Shareholders may be individuals, corporate entities or a combination of the two.

2. DWC LLC(Multiple ownership)

Can be from 1-50 shareholders (individual, corporate or both) Minimum share capital: AED 1,000 (USD 272) per shareholder Value of each share: AED 1000 (USD 272)

3. Branch (connected to an existing Company)

Existing companies can establish a Branch of their parent company. No share capital is required.
